All communications between the UNH Survey Center and the Nashua Chamber of Commerce or any persons acting on its behalf referring or relating to the construction, design or formulation of questions in the opinion poll conducted by the UNH Survey Center for the Nashua Chamber of Commerce (the "Opinion Poll"), which Opinion Poll was purportedly described

2. All communications between the UNH Survey Center and the Nashua Chamber of Commerce or any persons acting on its behalf referring or relating to the interpretation of the results of the Opinion Poll.
3. All other communications between the UNH Survey Center and the Nashua Chamber of Commerce referring or relating to the Opinion Poll.
4. All communications between the UNH Survey Center and Northeast Utilities, PSNH and/or Northern Pass Transmission LLC or any persons acting on their behalf, referring or relating to the construction, design or formulation of questions in the Opinion Poll.
5. All communications between the UNH Survey Center and Northeast Utilities, PSNH and/or Northern Pass Transmission LLC or any persons acting on their behalf, referring or relating to the interpretation of the results of the Opinion Poll.

All documents containing reference, guidance and/or practice and procedure information employed by the UNH Survey Center to remedy misleading impressions or incorrect interpretations of the work of the UNH Survey Center when such misrepresentations or incorrect interpretation is disseminated by the sponsor of that work.
10. All documents referring or relating to the instructions given to the individuals conducting the Opinion Poll with respect to their communications with respondents.

14. All documents showing who paid for the Opinion Poll.
